COURTS OF JUSTICE FEES ACT (R.S.A. c. C135)

**HIGH COURT FEES (CIVIL, ADMIRALTY AND  
OTHER PROCEEDINGS) REGULATIONS**

---

Note: These Regulations are enabled under section 1 of the Courts of Justice Fees Act, R.S.A. c. C135.

**Fees**

1. The fees or percentages required to be paid in the High Court, in any office connected with the High Court or for services by any officer attached to the High Court who is paid out of public money are as follows—

- (a) for each item set out in Column 1 of Schedule 1 in respect of civil proceedings, the amount set out opposite in Column 2;
- (b) for each item set out in Column 1 of Schedule 2 in respect of admiralty proceedings, the amount set out opposite in Column 2;
- (c) in respect of other proceedings the amount set out in Column 2 of Schedule 3.

**Fees to be paid in stamps**

2. The fees payable in all proceedings in the High Court in all its branches shall be taken in stamps authorised under the Stamp Act.

**Stamps may express gross fees**

3. Any number of separate fees may be expressed on a document by 1 or more stamps for the gross amount.

**Use of stamps**

4. The stamp or stamps shall be affixed to the document in respect of which the fee is payable; but where any fee is payable in respect of any matter or thing in reference to which it is not customary or may not be necessary to use any document or paper, the party or his solicitor requiring the matter or thing to be done shall make application for it by a præcipe or short note in writing or print to or upon which the stamp or stamps shall be affixed, and all papers and documents when possible shall be stamped on the left hand upper corner of the front sheet.

**Documents to be stamped before signature**

5. All documents must be fully stamped to the amount of the prescribed fees before being brought to the officer of the High Court responsible for the transaction involved, and the officer before signing the document shall satisfy himself that it has been correctly stamped.

**Cancellation of stamps**

6. Before any stamped document passes out of the possession of the officer of the High Court responsible for the transaction involved, the stamps on the document shall be effectively cancelled by the officer by means of a metallic date stamp and indelible ink; and in the case of stamps of a value higher than 24¢, each stamp must

be perforated with a punching machine in such a way as to destroy completely any philatelic value the stamp might otherwise possess.

**Accounts**

7. As soon as possible after the end of each quarter, the Registrar shall transmit to the Accountant General a statement signed by him certifying the amount paid by means of stamps in respect of all proceedings during the preceding quarter, and the statement shall be duly entered in the appropriate account.
